How Can Coins be Transferred from Coinbase to Ledger?

Coinbase is a <u>cryptocurrency exchange</u> that gives you the option of storing your bitcoin either online or in a physical wallet. You can store your cryptocurrencies in either the Ledger Nano S or Nano X, both of which are hardware wallets.

Most cryptocurrency exchanges allow you to keep your assets either online or offline in a hardware wallet, and Coinbase is no exception.

Coinbase to Ledger Nano X or S transfer

You must first set up your Ledger Nano S or X before you can transfer crypto from Coinbase to it. When downloading software, make sure that you follow the manufacturer's recommendations.

1.Plugging in your Ledger

The Ledger Nano X and S can be connected to your PC.

Using the Ledger Live App, type in your password

This step should be simple if you've already installed and downloaded the software on your Ledger device.

Choose the receive option from the menu on your left to bring up a funds receipt screen

Identify the Account You Wish to Credit

You'll have to decide the cryptocurrency you'd like to transfer to the device, as well as which account you'd like to transfer your digital assets from.

When you are done with this step, click the 'continue' button.

Open the Appropriate App on Your Ledger Mobile Device

Different coins can be received on your ledger device using the included programs.

Make sure you're using the correct app for the coin you're trying to transfer.

When you first set up your device, these apps should be pre-installed.

Make sure your Ledger device is connected to your computer and that you select the correct app for the coin you intend to transfer.

To proceed, click the 'continue' button on your computer's menu bar

Continue when prompted to validate the device's IP address. validate the device's IP address

Perform an Address Verification by Hand

Make sure your online wallet address matches your device's by performing this manual step. There is a button to the right of your Ledger device that you can use if they are the same.

If you've done everything correctly, your computer program will let you know. To copy the address, click the "copy" button.

Log in to Coinbase.com

Log in to your Coinbase account once your gadget has been set up and is ready to receive your crypto.

3. Select a Coinbase Wallet

4. The Ledger Address is as Follows

Due to the fact that your Ledger device is a cold, offline wallet, you must enter the unique address that is provided with it.

It's also possible to attach a note, which will serve as a reminder to retain a record of the changeover.
